ORDINANCE No. 676
ANNUAL APPROPRIATIONS ORDINANCE

AN ORDINANCE OF THE CITY OF GOODING, IDAHO, ENTITLED THE ANNUAL APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2011, AND ENDING ON SEPTEMBER 30, 2012, APPROPRIATING THE SUM OF \$3,716,757.00 TO DEFRAY THE EXPENSES AND LIABILITIES OF THE CITY OF GOODING FOR SAID FISCAL YEAR, AUTHORIZING A LEVY OF A SUFFICIENT TAX UPON THE TAXABLE PROPERTY AND SPECIFYING THE OBJECTS AND PURPOSES FOR WHICH SAID APPROPRIATION IS MADE.

BE IT ORDAINED by the Mayor and City Council of the City of Gooding, Gooding County, Idaho as follows:

Section 1: That the sum of \$3,716,757.00 be, and the same is appropriated to defray the necessary expenses and liabilities of the City of Gooding, Gooding County Idaho for the fiscal year beginning October 1, 2011.

Section 2: The objects and purposes for which such appropriation is made, and the amount of each object and purpose is as follows:

Section 3. That the general tax levy of \$830,678.00 on all taxable property within the City of Gooding be levied in an amount allowed by law for the general purposes for said City, for the fiscal year beginning October 1, 2011.

Section 4. All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

Section 5. This ordinance shall take effect and be in full force upon its passage, approval and publication in one issue of The Times News, a newspaper of general circulation in the Magic Valley, and the official newspaper of said City.
