The utility charges include but are not limited to: water (potable), sewer, garbage and reconnect fees. The undersigned agrees to pay \$100.00 deposit upon signing of this application and agreement. If the account is current for a period of 2 fiscal years the deposit will be refunded upon application of said user. If the account is delinquent (not paid by the 20<sup>th</sup>) any time during the first 2 years, the deposit may not be refunded. The deposit may be applied to any amount owing to the account upon termination of services. If the undersigned does not leave a forwarding address upon termination, the funds may be dispersed to the Idaho State Unclaimed Funds Depository.

The undersigned agrees to pay all utility billings not later than the 20<sup>th</sup> of each month. **Services may be discontinued any time on or after the 25<sup>th</sup> of each month in the event that the payment is not made on or before the 20<sup>th</sup> of the month.**

The undersigned agrees the City can place a lien on the real property at the service address for the utility amount delinquent for a period of 90 days or longer. If a lien is unable to be placed on the real property the undersigned agrees the delinquent utility amount, for a period of 90 days or longer, will be sent to Statewide Collections.
